Guidelines regarding the processing of your personal data in accordance with art. 13 of the European Data Protection Regulation (GDPR)

### **Storage of personal data:**

The association stores and processes your submitted personal information solely for membership administration and association management purposes. These are specifically your name, address, e-mail address, telephone number date of birth, bank account, payment data concerning membership fees and donations and date of entry and cancellation. The legal basis is your declaration of consent regarding your membership application as well as the association's legitimate interest concerning an organised membership administration. (art. 6 para. 1 lit. a and lit. f GDPR)

Your personal data will not be transmitted to third parties without your separate and expressly obtained approval.

Your data will be deleted two years after your membership cancellation or respectively after the legal data retention period.

Further data that you have provided for the extended membership list on our homepage will only be disclosed in a password-protected area restricted to members. After membership cancellation, the data will be deleted.

Personal data also collected from non-members during association events will likewise be stored until the expiration of the legal data retention period. (Legal basis: art. 6 para. 1 lit. a and lit. f GDPR)

At irregular intervals we send newsletters and other information on topics relating to historical dance to association members and interested persons (Legal basis: art. 6 para. 1 lit. f GDPR). The consignment can be refused at any time by a simple notification to the association ([info@danceandhistory.org](mailto:info@danceandhistory.org))

### **Rights of the data subject:**

As the data subject, you retain the right to at any time request information as to which of your personal data have been stored with us. You may induce corrections, restrict further processing and demand the deletion of data not required for proper membership administration.

Declarations of consent for data storage issued to the association may be revoked at any time.

All parties concerned are entitled to lodge a complaint with the competent supervisory authority (Bayerisches Landesamt für Datenschutzaufsicht, Promenade 27, 91522 Ansbach)
